

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to <http://www.settingschristian.com/>, and Settings Christian Publishing, LLC and governs data collection and usage. The Settings website is a Professional Services site. By using the Settings website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, Settings may collect personally identifiable information, such as your:

- First and Last Name

- Mailing Address
